I have memories of my mother, Susanna E. (Conine) Reicha taking me to the Old Mission Inn to visit my Great Grandmother, Katherine (Heimforth) Porter who at that time owned and operated the Old Mission Inn along with her husband Alfred E. Porter. She would show me the places where she worked there and told me what went on there. It was a popular place to go for Dinner after which the men would retire to the smoking room where they could enjoy their cigarette or cigars and a nice after dinner drink. Women were not permitted in this room as it was for men only. The women went with children if present into the parlor. I remember swinging on the swings in the front yard and visiting the barn that was toward the back of the property. I remember my visits because Great Grandma Kate seemed like a stern woman and would not stand for any nonsense.

My mother used to tell us kids stories about her work there and told us that Grandma Kate was a stern task master. Things had better be done right or you had to do it all over and over until you got it right.


