Hello Steering Committee Members-

Following up on my message from a few days ago, please see two attachments. I attached a list of contacts for each member in case you need it. I also attached a chart showing areas of interest areas expressed by each member in recent emails. Dave Murphy also raised three good questions about steps going forward.

He first asked about collaborating based on replies. My take away from our last meeting was that we want to encourage informal conversation among members who share interests while we wait for normal meetings to resume (hopefully soon). We are scheduled to meet again on June 1. At that meeting we can certainly discuss how this can evolve into a more formal subcommittee structure going forward. I see that we have a pretty good distribution of interests (except for Cultural Anchors which we should also talk about).

Secondly, Dave asked about discussions with others (outside the Committee). I think reaching out to individuals and groups who share interests and have particular insights will be great.

The third question raised was if we should look for a group report or individual responses. I believe that when we meet again, we should share individual observations and insights to the topics committee members are associated with. I think this includes whether additional consideration further shapes and expands the key question(s) listed.
